Another accomplishment was a much needed overhaul of our Information Technology infrastructure.

Tycoon Executive Services completed a face lift to our website www.resicare.org in January. This clean design is easy to navigate while providing necessary functionality.

CRC Check installed a network server and networking equipment to consolidate files and allow access into a single network. These changes have provided a seamless e-mail environment and a more robust system with broader coverage.

Our Management team met on a regular basis with our Contract Specialist, Team Leader and Service Coordinator from Persons with Developmental Disabilities. These meetings provided an opportunity to address client changes, concerns and any other pertinent issues. We appreciate the positive working relationships and support offered to Resicare through PDD.

A new initiative was established in preparation for our annual Accommodation Standards (32 Standards) inspection in May and our upcoming CET (47 Standards) survey in January 2016. Two part time front line staff were hired two days a week and a consultant for one day a week to take leadership in this role.

Any Homes where four or more individuals reside fall under the Supportive Living Accommodation Licensing Act (SLALA). Another set of Safety Standards apply to homes where one individual with complex needs or two or more unrelated adults live, where overnight staffing is provided. The Alberta government put seven (7) PDD Safety Standards in place December 2012. An additional Safety Standard came into effect April 1st of this year to ensure these residences meet the Public Health Act, Safety Codes Act, local zoning by law and requirements that apply universally to all landlord and tenant settings in Alberta. Standard 8 provides assurance that residences where PDD-funded individuals live meet these requirements.

The three group living homes owned by Resicare are diligently monitored for health and safety. One of the homes required a new roof, eve troughs and fascia replacement this year. Several appliances needed replacement as well as incidental repair and service calls in all homes.

In 2012 safety measures for monitoring hot water temperature were legislated due to a serious incident in a PDD-funded group home. Resicare installed plumbing hardware to meet these requirements and continues to monitor around these regulations. Additional plumbing was done in March of this year to ensure safe water temperature. The system is monitored bi-annually on a contracted call back system.

We are very thankful for programs like the United Way Days of Caring and the Alberta Job Corps. They did extensive work for us this year and helped us maintain our homes at a level that portrays pride of ownership for everyone who resides there and call this home. The numerous projects and pictures are outlined in this report. Thank you Alana Delong, Calgary-Bow MLA for connecting us with The Electronic Recycling Association, who donated seven refurbished laptops to us.



Congratulations to four athletes who competed in their respective sports in Grand Prairie Alberta with Special Olymipics Provincal Games in February:




They were excited to be selected to participate in the National Winter Games next February in Corner Brook, Newfoundland.




