# Update August 7, 2024



The Government of Alberta announced an indefinite hold on the Canada-Alberta Job Grant program.

We know this will be distressing news to many of you who rely heavily on this funding to ensure essential training for your staff. We have addressed our concerns about the impact of this decision on the Community Disability Services sector in an initial response on social media this afternoon, and we will follow up with letters to relevant Government of Alberta ministers in the coming days, in addition to other advocacy efforts. We want to assure you that we will advocate strongly for access to funding to support staff training.

To assist us as we move forward with our advocacy, we request you share any information you can about how you currently use the Canada-Alberta Job Grant program, how many staff members benefit, in addition to other information you feel relevant. # **Seniors Services Home Maintenance**

The Seniors Services Home Maintenance (SSHM) program provides home maintenance support to seniors (65 years and older) living on lower fixed incomes in Calgary who are eligible for the provincial Special Needs Assistance for Seniors benefit program. Approved community partners deliver the services of light housekeeping, snow removal and grass cutting.

## What are eligible home maintenance services?

The Provincial Special Needs Assistance (SNA) for seniors benefit program has defined three main areas for home maintenance as allowable services paid out by the SNA benefit. If eligible, these defined service provisions are:

- ♦ Light housekeeping, dusting of surfaces, vacuuming/mopping of floor surfaces, cleaning of kitchen and washrooms (does not include laundry).
- Grass cutting: front and back lawn, medians associated with property
- Snow removal: the primary entryway, driveways, wheelchair ramps and public sidewalks bordering the property.

Housekeeping and grass cutting service frequency is set on a schedule with each individual who participates in the program. Snow Service will be delivered within 24hrs after a snowfall event of one inch (2 cm).

## Who is eligible?

To be eligible, seniors must be 65 years of age or older and unable to do basic housekeeping, snow removal or grass cutting.

Generally, there is a waiting period for all services, which may vary according to service type and client location. Our aim is to minimize the waiting period as much as possible.

#### How to access home maintenance services

Seniors must apply for **Seniors Service Home Maintenance through the <u>Fair Entry Program</u> and must be eligible for the Special Needs Assistance (SNA) for Seniors secondary benefit coverage. The SSHM program will confirm your eligibility for SNA and let you know how to find out more about the program or appeal your status.**

Cost

There is no direct charge to clients receiving the services of light housekeeping, grass cutting and snow removal services. Service costs are recovered on behalf of clients eligible for the Special Needs Assistance for Seniors benefit program and is processed via direct billing to the Government of Alberta on the client's behalf.



# <u>Training</u>

**Medication Administration** - The employees who have not started the Med Admin, please do so as soon as possible as vouchers do expire and you will need to be re-registered.

**Citation Training** - Please activate and complete trainings.

**Emergency First Aid/CPR -** Nadia will register employees for recertification through Titan Heath.

**Alberta Food Safety Basics -** Instructions will be emailed to the employees who require this training.

# Resicare's Insurance

# **Health and Safety Act**

The Alberta *Occupational Health and Safety* (OHS) Act establishes minimum standards for healthy and safe practices in Alberta workplaces. Changes to the OHS Act improve the OHS system to better protect—workers and ensure they have the same rights and protections as other Canadian workers. These rights include:

**Right to Know** – This right guarantees that employees can ask questions about health and safety at work and be informed about hazards – and protections from hazards – that concern them.

**Right to Participate** – To participate in workplace health and safety allows employees to get involved in maintaining and improving health and safety in their own workplace.

**Right to Refuse** – To refuse unsafe work ensures that employees are protected from punishment or threat of punishment if they refuse to do work because of a sincere belief that work threatens their own or anyone else's health or safety.

The Right to Participate ensures all workers have a voice by expressing their concerns with a **Joint Work Site Health and Safety Representative.** At Resicare Society of Calgary each Group Living Home has a Health and Safety Representative working in conjunction with the management team.
